## Data Controller

## Purpose, legal basis and optional nature of data processing

Your Personal Data will be processed for the purpose of selecting and assessing Applicants for possible employment or collaboration with Fulgis.

The legal bases of data processing for the above-mentioned purpose are:

- Art. 6 par. 1 lett. b) GDPR "processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract". The provision of your Personal Data for the above-mentioned purpose is required in order to assess your professional skills.
